#### <u>Behaviour consultation package -</u> What's included?

## **Behaviour Consultation** Up to 2.5 hours

This is held at your home or remotely (e.g. over zoom). During the behaviour consultation, I ask lots of questions regarding your dog, their history, background and behaviour. I then discuss the cause of the behaviour, and strategies for you to help manage and treat the behaviour. If we have time, we might practise any relevant training or go for a walk.

## **Behaviour Report**

You will then be sent a tailered behaviour report both through the post and over email detailing all we discussed during the consultation. This includes the behaviour summary, causes, safety risks, and strategies to manage the behaviour.

This will accompany any additional training materials and information in a supplementary pack.

A copy of the report will also be sent to your referring vet, along with any necessary communications to discuss medical aspects of the case.

## Follow-up Appointment 1-hour

This will either be held at your home, in a park, field, secure dog field or remotely. During the followup session, we discuss progress, any questions or concerns you may have, and we will discuss (and maybe practise) any necessary behaviour modification training.

Additional follow-up appointments can be booked for an extra fee.

You will also be provided with remote support in the form of email, phone calls or text for up to 3 months after the consultation.

## How to book a consultation

# **Step 1: Get in touch**

## Step 2: Choose a date and time

You will be sent a list of dates and times to choose for the behaviour consultation appointment.

# Step 3: Payment

#### Once a date has been chosen, a 25% deposit is required for the booking to be secured.

Please note: Unless the 14 day 'cooling-off period' applies, the 25% deposit (or 25% of the full payment made) will not be refundable if you decide to cancel your booking within 5 calendar days of the arranged consultation date. # Step 4: Veterinary Referral

I require a signed referral form from your vet concerning your dog before the consultation can take place. I may also need this for any other dogs in the home too. Your vet may first want to check your dog over for any signs of pain or medical issues that could be affecting the behaviour.

#### <u>Why is this important?</u>

Many behaviour problems are caused or affected by pain or medical issues. These issues may not be obvious, so it's important your vet rules this out before I provide a behaviour diagnosis and treatment plan.

# **Step 5: Questionnaire**

You will be asked to complete and return a questionnaire regarding your dog at least a week before the consultation.

- I only work on veterinary referral, to rule out pain or medical issues contributing to the behaviour before I provide advice.
- I use the most scientific up-to-date methods, involving reward based training. I do not advocate the use of punishment, and I value safety and animal welfare above all.

## **Polite note:**

- I will not be able to 'cure' your dog's behaviour concerns. My services are aimed at providing you with advice necessary for YOU to manage and change your dog's behaviour. I will support you through this process through the provision of advice and (in some cases) training instruction, and it is YOUR responsibility to put any recommended changes in place.
- My service fee for in-person sessions only covers a 40-mile radius of Cresswell, Stoke-on-Trent. If you live outside of this 40-mile radius, I will charge an additional £1 per mile.
- As I have limited dates and times available for consultations, I operate a first come, first served basis with bookings. Therefore, if you are interested in a specific date for the consultation, then this will be reserved for 3 working days until payment is received. If the payment is not received, then the consultation date and time may be offered to someone else.
